ORDINANCE

REQUEST TO REZONE FROM A-AGRICULTURE TO R-MH RESIDENTIAL APPROXIMATELY 86.167 ACRES OWNED BY TWO HUNDRED & FIFTY ASSOCIATES, INC., LOCATED ON THE SOUTHWEST SIDE OF ROUTE 250 JUST EAST OF THE STAUNTON CITY LIMITS IN THE BEVERLEY MANOR DISTRICT.

AN ORDINANCE to amend Chapter 25 "Zoning" of the Code of Augusta County, Virginia.

WHEREAS, application has been made to the Board of Supervisors to amend the Augusta County Zoning Maps,

WHEREAS, the Augusta County Planning Commission, after a public hearing, has made their recommendation to the Board of Supervisors,

WHEREAS, the Board of Supervisors has conducted a public hearing,

WHEREAS, both the Commission and Board public hearings have been properly advertised and all public notice as required by the Zoning Ordinance and the Code of Virginia properly completed,

WHEREAS, the Board of Supervisors has considered the application, the Planning Commission recommendation and the comments presented at the public hearing;

NOW THEREFORE BE IT ORDAINED, by the Board of Supervisors that the Augusta County Zoning Maps be amended as follows:

Parcel Number 25 on Map Number 56D1(1) is changed from A-Agriculture to R-MH Residential. The following conditions which were proffered in writing by the owner, prior to the public hearing, are approved and shall be appurtenant to the R-MH Residential zoning of this property:

- A. The mobile home park will contain the following:
 - 1. County Water
 - 2. County Sewerage
 - 3. Paved Streets
 - 4. Underground Electric
 - 5. Underground Telephone
 - 6. Underground Cable TV
 - 7. Adequate provisions for surface drainage
 - 8. Each lot will have Road Frontage
 - 9. Street Lighting as neccessary will be provided
 - 10. Suitable Recreation area and Play Ground areas will be provided
 - 11. Off Street Parking
 - 12. All units must be underpinned

- 13. Off Street Parking spaces per lot
- 14. Fencing will be provided around perimeter
- B. 250 Associates, Inc., will grant to the Museum of American Frontier Culture a fifty foot (50') scenic easement along the Western Boundary Line that joins the Commonwealth of Virginia property for a distance of 1,260.31 feet. This easement is for use in planting as seen necessary, if the Frontier Museum sees fit. We also grant the museum the right to plant trees to screen any buildings visible from their property as long as it does not interfere with the construction or development of our property.
