In response to your request for information regarding the above referenced property, please be advised of the following:

- 1. The Augusta County Community Development Department is responsible for the enforcement of all applicable Zoning ordinances, regulations, and codes regarding development in this jurisdiction.
- 2. The property is currently zoned General Business. It is not part of a Planned Unit Development. The existing restaurant is a permitted use in a General Business District.
- 3. The property lies within the Urban Service Overlay District.
- The property was subject to site plan approval. Copies of the site plan are available from Community Development Department for a cost of five dollars per sheet.
- 6. The General Business zoning district abuts this property on all sides.
- 7. The Community Development Department is unaware of any violations or claimed violations of any Zoning Ordinance, Building Code or regulations regarding the current uses, occupancy, operation or improvements on the property.

- 8. There were no variances or special use permits issued for this project.
- 9. All governmental permits and approvals necessary for the construction, use, operation and Certificates of Occupancy were issued when the building was completed. Copies of the Certificates of Occupancy are available from the Building Inspection Department upon request.
- 10. Per the Zoning Ordinance the current structure is a legal conforming use.
