ORDER TO SHOW CAUSE


Pursuant to subsection A of Va. Code § 15.2-1643, it appears to the Circuit Court for Augusta County, from the reports of persons appointed to examine the following court facilities, or otherwise, that the Augusta County Circuit Courthouse located at 1 East Johnson Street in Staunton, Virginia, and the District Courts Building for the Augusta County District and Juvenile & Domestic Relations Courts located at 6 East Johnson Street in Staunton, Virginia (collectively,

the "Courts Facilities"), are insecure, out of repair, or otherwise pose a danger to the health, welfare and safety of court employees or the public.

WHEREFORE, this Order is entered, in the name and on behalf of the Commonwealth of Virginia, against the Supervisors of Augusta County hereby ORDERING them to show cause why a mandamus should not issue, commanding them to cause the Court Facilities to be made secure, or put in good repair, or rendered otherwise safe as the case may be, and to cause the necessary work to be done.

The Clerk of the Augusta County Circuit Court and the Augusta County Sheriff are hereby requested to cause a copy of this Order to Show Cause to be served upon each Supervisor of Augusta County, as provided in subsection A of Va. Code § 15.2-1643.
