This letter is in reference to property owned by Augusta Best Western Associates, Limited Partnership and is more specifically identified on Augusta County real estate map 56D1 (1) as parcel 20.

In response to your request for information regarding the above referenced property, please be advised of the following:

- 1. The Augusta County Community Development Department is responsible for the enforcement of all applicable Zoning ordinances, regulations, and codes regarding development in this jurisdiction.
- 2. The property is currently zoned General Business and is located within an Urban Service Area and contains an existing motel.
- 3. Per the Zoning Ordinance and regulations for this area, the current structure is a legal conforming use.
- 4. Section 25-302N "Permitted Uses" of the Augusta County Zoning Ordinance states: "The following uses shall be permitted within General Business Districts without Administrative or Special Use Permit, provided there is no outdoor storage or display: Overnight accommodations, including but not limited to: bed and breakfast inns, motels, hotels."
- 5. The property was subject to site plan approval. Copies of the site plan are available from Community Development Department for a cost of ten dollars per sheet.

- 6. All required permits and approvals necessary for the construction, use, operation and Certificates of Occupancy were issued when the building was completed. Copy of Certificate of Occupancy is included.
- 7. The Community Development Department is unaware of any violations or claimed violations of any Zoning, or Building Code violations, and or complaints on this property.
