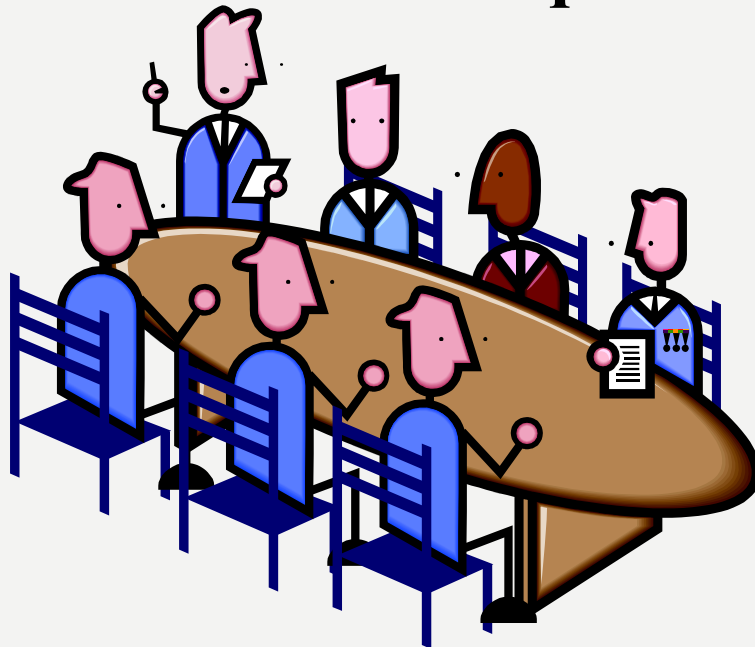

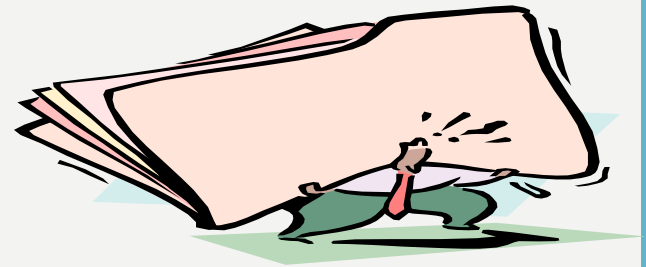
# Workload

**Special Use Permits**-The Board held eighty-five (85) Public Hearings on these requests. Seventy-one (71) were approved with restrictive operating conditions, eight (8) were denied, four (4) withdrew, and two (2) are on hold.

**Variances**-The Board held two (2) Public Hearings on Variance requests. Both requests were approved.

**Extensions of Time**-The Board issued eighteen (18) Extensions of Time.

**Cancellations**-The Board cancelled two (2) permits.

# Short Term Vacation Rentals
