Scope: This quote shall include all materials and labor to complete the partial carpet replacement within the timeline provided per this RFQ.

Size: Floor area sq. ft. is approx. 8,076

Carpet Specification: Carpet Tile Manufacture – Mannington, Style Name – Seeds, Color Chaotic

VCT Specification: VCT Manufacture – Tarkett, Color/Style - #325

Vinyl Base Specification: Vinyl Base Manufacture – Johnsonite, Color/Style - #29

Notes:

- 1. Any substitute product must be equal or better product and approved by owner. Please submit substitute documentation to Rusty Sprouse, rsprouse@co.augusta.va.us.
- 2. All existing vinyl base will be removed by the painting contractor prior to carpet installation.
- 3. All existing carpet will need to be removed by the contractor awarded the carpet replacement.
- 4. Floor leveling and all materials and labor required to make these repairs must be included in pricing for the carpet replacement.
- 5. The County will communicate with the contractor awarded the project on the carpet lay pattern.
- 6. Touch up painting scheduled for the week of December 23, 2024.

Timeline: The first day of work will proceed on Tuesday, December 9, 2024 and will need to be completed by Friday, December 20, 2024. Timing is crucial, as painting touch up are scheduled for the week of December 23, 2024 and a move in date of January 2, 2024.
