2-11	<u>BARTERBROOK INVESTMENT CO., LLC - REZONING</u> Consider a request to rezone a total of 86.47 acres from General Agriculture and Multi-Family Residential to Single Family Residential with proffers (34.73 acres), Attached Residential with proffers (26.73 acres), Multi-Family Residential with proffers (25 acres), owned by Barterbrook Investment Co., LLC and located on the west side of Barterbrook Road (Route 635) approximately 0.4 of a mile south of the intersection with Frontier Drive (Route 644) near the City of Staunton (Beverly Manor District). The Planning Commission recommends approval with revised proffers.
2-12	<u>ZONING ORDINANCE AMENDMENT</u> Consider an Ordinance amending the Zoning Ordinance of Augusta County Related to signs in Public Use Overlay Districts. This ordinance amends § 25-47 in Article IV. Signs, billboards and outdoor advertising structures by allowing signs in Public Use Overlay Districts to be under the same maximum size and number restrictions as properties zoned Business or Industrial. Currently the signage restrictions for properties in Public Use Overlay districts are governed by their underlying zoning classifications. The Planning Commission recommends approval of the Zoning Ordinance Amendment.
