# 12-07 BARKING DOGS ORDINANCE

Consider an ordinance to enact Section 15-9 to the Augusta County Code to declare that the howling or barking of dogs for more than ten consecutive or non-consecutive minutes in any 30-minute period of time between 12 midnight and 6 a.m. on property zoned Single Family Residential, Attached Residential, Multi-family Residential, Manufactured Home Park, or Planned Unit Development shall constitute loud, disturbing and unnecessary noise and constitute a violation of the County Code. This ordinance will also amend Section 15-11 of the Augusta County Code by providing that the fine for violating Section 15-9 will be a fine of \$100 for the first offense, \$250 for the second offense in a year, and \$500 for the third and subsequent offenses in any one year. This item was tabled at the Board of Supervisors November 25, 2014 Regular Meeting.
