Workload

Special Use Permits-The Board held sixty-one (61) Public Hearings on these requests. Fifty-five (55) were approved with restrictive operating conditions, three (3) were denied, one (1) cancelled, and two (2) were withdrawn prior to advertisement.

<u>Variances</u>-The Board held two (2) Public Hearings on Variances. Both requests were approved.

Extensions of Time-The Board issued seven (7) extensions of time.

Appeal of the Zoning Administrator's Decision- The Board heard one (1) appeal and upheld the Decision of the Zoning Administrator.





KENNELS

Kennels-The Board had five (5) requests to operate a dog kennel and one (1) to operate a boarding and grooming only facility. All of the requests were approved.

Special operating conditions were placed on each kennel.

One request was for a family member to continue an existing kennel which was approved, but the number of dogs was reduced from 150 down to 75.
